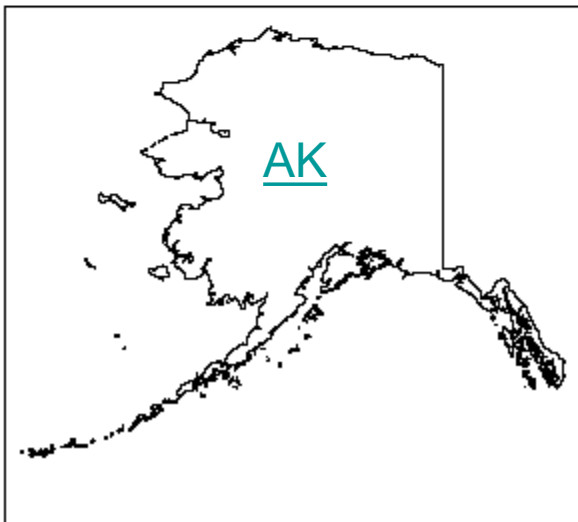
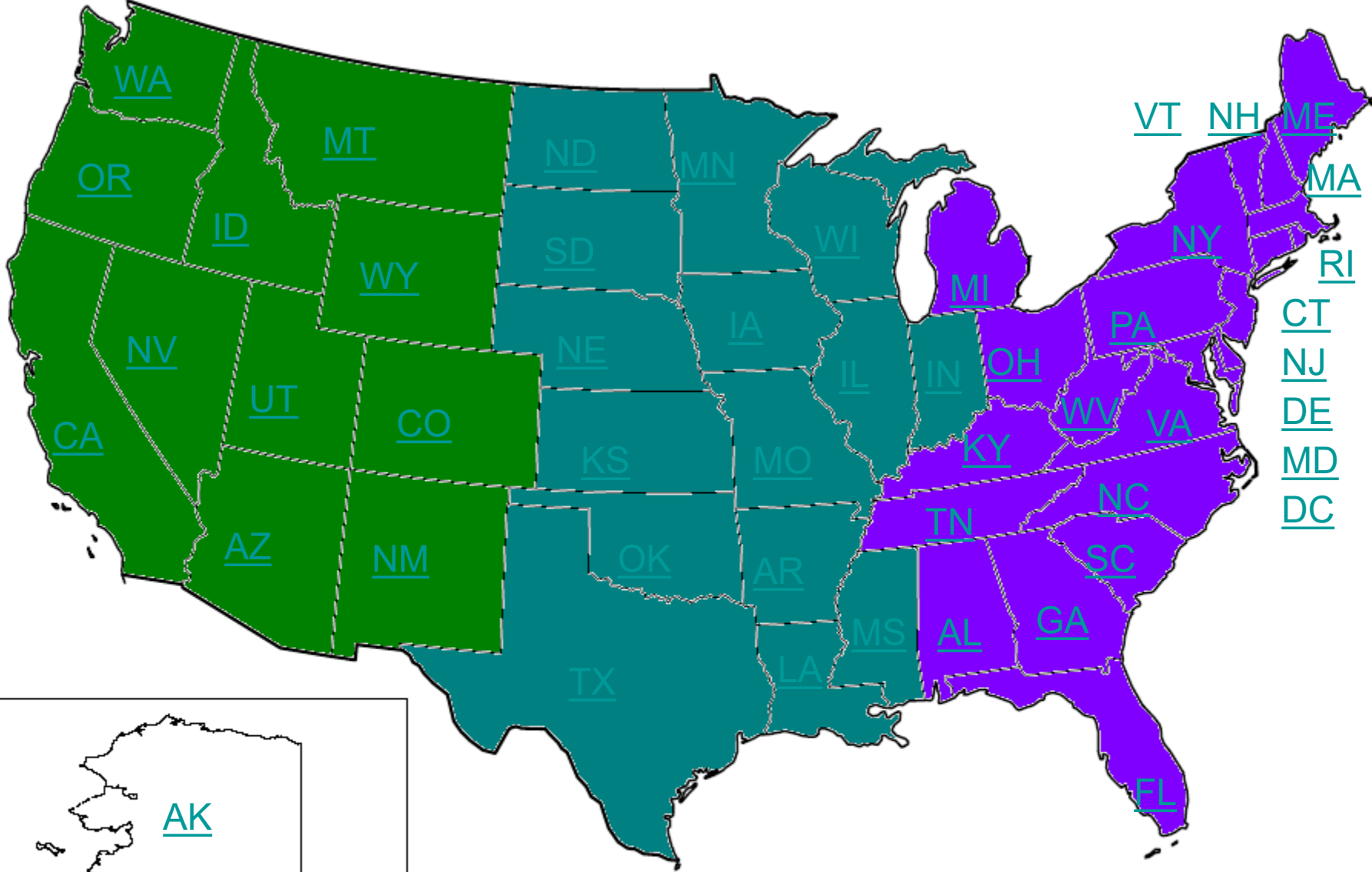

- \$5 DAV Hunting & Fishing License allows Resident 40% or higher service-connected Disabled Veterans to purchase reduced fee tags for deer \$10.75, elk \$16.50, bear \$6.75, or turkey \$10.75.
- Free campsite pass and park pass at 100% Rating
- Military Furlough Combination Hunting/Fishing @ \$17.50 (Idaho residents on Active Duty; must provide LES)
